Paralympic Winter Games

The Paralympics Winter Games is just around the corner. There are many things you can enjoy during 9 wonderful days, including the Opening and Closing Ceremonies and sports competitions. Don't forget the Journey of Fire, it is a very special vibrant event that each city will host an exciting celebration. It is a special way of bringing the fire from each city to a certain place to begin the Paralympic Winter Games.

An interesting note about Paralympic history: It all began as a dream of a English neurosurgeon, Sir Ludwig Guttman. He wanted to provide athletes with disabilities the opportunity to compete at an international level equivalent to that of non-disabled athletes: an Olympics for athletes with disabilities. Originally started in 1948 as rehabilitation for injured WWII veterans, the Paralympic Games were held for the first time in Rome with 400 athletes representing 23 countries. "Paralympic" is commonly thought to have been taken from the word "Paraplegic" but "Para" is a latin prefix for "with", making the literal transition "with olympic". The Paralympic Games have been parallel to the Olympic Games since their inception. Journey of Fire Event

The Paralympic Journey of Fire is a vibrant six days of ceremonies meant to continue the high level of excitement between the Olympic Closing Ceremony and the Paralympic Opening Ceremony. The Journey of Fire is a symbolic movement of fire coming to Salt Lake City. Each community will use tools provided by the Paralympics to develop their own Journey of Fire Community Celebration.

You may wonder where the flame comes from since the Olympic's flame began in Athens, Greece. The Paralympic's flame is very special. It comes from the cities where the Paralympic Games are being hosted. Each city will develop their own program on how the flame is lit. It could come from a Special Candle ceremony. For centuries, candles have been used as a way to light our paths. When people enter the program, they are given a candle and asked to light it from another candle. After the

whole crowd has lit their candles, one of them lights the cauldron. This symbolizes that everyone has touched the same light. The cauldron could be lit from a fire already burning in the community such as a memorial flame. If there is a local cultural tradition on fire such as Native American traditions, it could be used to light the cauldron. A last option to light the cauldron is a campground fire, since tourism is a big part of many of the communities on the Journey of Fire, it could be light a campfire before the ceremony begins to transfer it to cauldron. These different ways of lighting up the cauldron can be done in a special way. It should not come from a pocket lighter, a barbecue grill, or other non-ceremonial source.

The following cities and dates will be hosting their own special celebrations.

March 1, American Fork Public Library at 7:00 pm, Brigham City's Courthouse steps at 6:30 pm, Moab Swanny Park at 7:00 pm, and Woods Cross Hogan Park at 6:00 pm.

March 2, Cedar City Canyon View High School at 1:00 pm, Heber City's City Park at 10:30 am, Kaysville Old Fire Station at 11:00 am, and Sandy's Sandy City Hall at 6:00 pm.

March 4, Layton Northridge High School at 6:30 pm, Park City Olympic Welcome Plaza at 5:00 pm, St. George Tuacahn Theater at 5:30 pm/7:00 pm, and West Valley's West Valley Family Fitness Center at 7:30 pm.

March 5, Centerville/Farmington Centerville Junior High School at 6:30 pm, Murray's Salt Lake City Ice Rink at 6:00 pm, and Springville Arts Park at 7:30 pm.

March 6, Paralympic Flame Celebration at Salt Lake City and County Building at 6:00 to 7:30 pm. This celebration will bring the 15 community flames from each Community Celebration together to form one Paralympic Flame. Otto the Otter mascot will be featured in the program plus other activities. International Paralympic Committee President Philip Craven will be present.

March 7, the Paralympic Flame Run begins at the Salt Lake City and County Building at 10:00 am. One hundred runners will carry the Paralympic Flame from the City/County Building to the Rice-Eccles Stadium. The Paralympic Flame will be carried by over 100 runners, young and old, and people of all abilities, to travel to sites including the State Capitol, Liberty Park, to dedicate an abilities play-park for children, and to Shriner's Hospital then finally to Rice-Eccles Stadium for the Opening Ceremonies.

- Q: Who served the most number of years as UAD president?
- A: W. David Mortensen, who served a total of 22 years as president. He served from 1971 to 1985, 1987 to 1991, and 1993 to 1997.

He started out his involvement with the Utah Association for the Deaf as UAD Bulletin editor in 1968 and continues to be involved to this day, these days as editor of the Utah TTY Directory.

While serving as president, he worked nights at the Tribune, and went to University of Utah days to complete his bachelor's degree and obtain his Master of Social Work

degree. He worked for Valley Mental Health as a social worker with deaf clients.

During his presidency, United Way granted money to fund the Interpreter Program and to fund the TTY repair service. Dave began the Deaf Day on the Hill and started the UAD Friendship Day at Lagoon. The UAD was the first to manage the Relay Service in Utah. Dave did extensive lobbying at the Utah capitol, working to obtain phone surcharges to fund a relay service and TTY distribution program in Utah; supported a law recognizing ASL as a foreign language; worked extensively with legislators to obtain funding for the first Utah Community Center for the Deaf.

Opening / Closing Ceremonies Tickets

The Paralympics' Opening Ceremony will be held at the Rice-Eccles Stadium and the Closing Ceremony will be held at the Medals Plaza. Both ceremonies will have excellent interpreters provided by InterWest Interpreting Agency as part of an Olympics contract. You should not have any trouble in purchasing tickets. Tickets for the Opening Ceremony at Rice-Eccles Stadium will be \$25, \$50,and \$100 or \$20 dollars for groups of 20 or more. The Closing Ceremony at Olympic Medals Plaza will be \$50.

The Closing Ceremony will be the finale of a 37-day experience of the Salt Lake 2002 Winter Olympic Winter Games and Paralympic Winter Games. You can go to any Smith's store to purchase tickets to attend these two exciting and awesome events. Be sure to request Special Seating Sections.

Sport Venues Tickets

The Snowbasin Ski area will have Downhill, Super-G, Giant Slalom, and Slalom competitions. The Soldier Hollow area will have Biathlon, Cross-Country (short-distances, classical), Cross-Country (middle-distances, Free-style), Cross-Country (relay) and Cross-country (long distance, free-style). The E Center will have Ice Sledge Hockey.

Ice Sledge Hockey is a fast paced and highly physical game. It is nearly identical to Ice Hockey, with only a few minor changes in game format and rules. Athletes have lower-body disabilities and sit in double-bladed sledges. They use two sticks; each has a pick at one end, for pushing along the ice, and a blade on the other end.

Tickets can be purchased from any Smith's Food stores (Smithtix). The prices vary from Alpine Skiing competitions at Snowbasin Area for \$10 for adults and \$5 for children or groups of 20 or more to Nordic Skiing competitions at Soldier Hollow area for \$10 for adults and \$5 for children or groups of 20 or more. Sledge Hockey competitions at E Center are \$10 per Adult or \$5 for children or groups of 20 or more.

Television

The Salt Lake Organizing Committee and U.S. Olympic Committee had the television rights to the 2002 Paralympic Winter Games, but no station to show the competition. However, SLOC finally secured a network, Arts & Entertainment (A&E), which will air the Games daily in a one-hour magazine-style highlight program.

Starting March 9 at 4 p.m., viewers can tune into A&E for highlights of the Paralympic Winter Games sports

competition. Harry Smith and Joan Lundren will be the hosts of the network coverage. In addition to broadcasting the daily events, A&E's coverage will also include daily features on the athletes.

"We are excited to have such powerful television partners as A&E bring such an exhilarating sporting event to the United States," said Mitt Romney, SLOC president and CEO. "The amount of programming scheduled will allow fans to follow the Paralympic Winter Games as never before."

These are the first Paralympic Winter Games on U.S. soil. World-class athletes will compete in 100 medal events, including Alpine skiing at Snowbasin, Nordic skiing at Soldier Hollow and ice sledge hockey at the E Center.


The TTY Service Hotline is NOT limited to deaf and hard of hearing people, who are living with HIV, but to all who may concerns and/or want for accurate information about the disease.


