Do You Know About IP Relay?

This is an FYI for people who want to make a relay call on a computer without leaving the Internet. You enter www.ip-relay.com in your web browser and click on the box that says "Make a call." You may pick the Light Mode or Featured Mode. This IP-Relay is provided by MCI and allows you to use your computer and not have to dial any 800 numbers or even 7-1-1. It's very simple to use as long as you have the following on your computer:

- Windows 95 or higher
- Macintosh 8.1 or higher
- Netscape 4.7 or higher
- Microsoft Internet Explorer 4.0 or higher

This service is only for calls originated by text users, so hearing callers cannot call you back through this

Native Son Honored

At the USADSF Hall of Fame reception held recently in Indianapolis, Marvin Marshall was honored as an athlete. What you may not know is that Marvin, who is a retired teacher at the Indiana School for the Deaf, is a Utah native.

His athletic career was outstanding. During World War II, he was a Golden Gloves champ. He was already a seasoned boxer in Utah before entering Gallaudet as a prepster. He fought his first bout at the age of ten while at the Utah School for the Deaf. He has 12 championship titles from various AAU and Golden Gloves tournaments.

In 14 years, he fought more than 230 bouts. In his home state, he won the Utah Golden Gloves and the Inter-Mountain AAU championship several times. In 1942 he

won the District of Columbia AAU Championship by default, but was refused the award and asked for a match with the opponent who had previously forfeited. In this bout he lost by a close decision but gained a great amount of prestige. Fighting in the 126-pound class, the Mighty Mike won the District of Columbia Golden Gloves Championship in 1945 and earned an all-expenses trip sponsored by "The Washington Times-Herald" to New York City to take part in the Eastern Regional Golden Gloves finals.

At the Eastern Regional Golden Gloves finals at New York City, he was tabbed as the pre-tourney favorite to capture the 126-pound crown. In the semi-final bout, Marv's luck ran out on him as he lost a TKO to other boxer. The referee stopped the fight in the second round for fear that Marshall "might get hurt." He had received a cut in his face. This ended Marv's chance of gaining recognition in the boxing world.

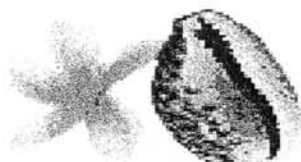

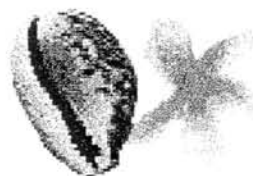
