## President's Message

WE NEED YOUR LETTERS/EMAILS/FAXES!

I received a phone call from Marilyn Call at 5:30 pm on Tuesday (June 25) about a Public Education Appropriations Committee meeting on Wednesday morning at 9 a.m. at the State Capitol.

Due to the budget deficit in Utah, one of the proposals to save money recommended consolidating the Utah State Office of Rehabilitation (USOR) with the Department of Workforce Services (DWS). This is a big NO! NO! NO! because the DWS has a very poor track record of meeting our needs. The Deaf Center would very likely be turned into a job service center for all people. In other words, it would not be a Deaf Center anymore. Blaine Peterson, USOR's Executive Director, spoke against the consolidation and did an excellent job. I attended the committee meeting but time ran out before I was able to say anything. Due to the UAD-Announce Email and a popular open-captioned movie, the word was spread and about 20 deaf people attended the committee meeting. THANK YOU FOR COMING AND SHOWING YOUR FACES!

It is vital that everyone lobby the members of the committee to "LEAVE THE USOR AND DEAF CENTER ALONE!" We will have an emergency board meeting on June 29 at the Deaf Center and then a public meeting afterwards to assist the public to write letters / emails / faxes to the legislative committee to lobby against the consolidation recommendation. People on the UAD-Announce email service have been kept up to date on the news and meetings. If you have not joined the UAD-Announce email service, do it now! Simply send your email address and name to Clay Crye at clay@crye.net and ask him to put you on the UAD-Announce. Please find more information at www.uad.org/lobby.htm with instructions on how to contact the Legislative committee members.

The UCCDHH is the ONLY place in Utah that is designed to meet the unique needs of a unique segment of Utah's population, the Deaf and Hard-of-Hearing. Based on the United States Census 2000 issued April 2001, the population in Utah is 2.2 million and approximately 10% of the population are Deaf and Hard-of-Hearing. This represents a significant portion that cannot be ignored or their needs put aside. If we will make our concerns known by lobbying, they will listen to us. It is up to you. Each letter/email/fax makes a difference! It is a difficult communication problem.

Rob Kerr and I will be at the NAD Conference as UAD Delegates when you read this. I was asked to serve on the Steering Committee and the Resolutions Committee. We will give a report at the UAD General Meeting on September 21, 2002. Please jot this date down.

\*Authorized the purchase of a quarter page advertisement in the Miss Deaf America Pageant program book.

\*Accepted Wayne Stoltz's resignation as board member.

\*Authorized the payment of \$1,625 for registration fees and hotel lodging for Miss Deaf Utah, chaperone and state director. This is a loan against the MDUP fund, to be repaid by December 31, 2002.

\*Allowed UACD to affiliate with the UAD, for a fee of \$25.00; the affiliation will expire August 31, 2002. June 8, 2002

\*Administered the oath of office to new directors - Eli McCowan, Boyd Collins, April Trocki and Max Hardy.

\*Agreed to extend the affiliation with UAD by Utah Athletic Club of the Deaf to May 31, 2003.

What is Partners in Policy-Making Training (PPM)?

It is hosted by the Governor's Council for People with Disabilities. The mission of this state-of-the-art training is advocacy for public policy that affects all people with disabilities in the state of Utah. The PPM is designed to educate and empower its participants to achieve policy

> change at the local, state, and federal levels. The curriculum contained a huge amount of information about advocacy. From leaders in the field, we learned histories, philosophies, and concrete strategies for creating systemic change in disability areas.

From September 2001 to May 2002, I attended the positively overwhelming training for two days a month except during the holidays and Olympics. (They were made up twice in March.) I learned that I was the first Deaf participant in this state-wide program (GCPD). Interpreters were



provided at every training session. At the graduation last month, we had a bittersweet graduation ~ it had been a long haul but our confidence had grown! Allison, the new Executive Director of GCPD, replied that there would be a short-version advanced training from time to time every year. What a perfect gathering to share our 'hand-on' experiences of advocacy at our reunions!

What is coming this fall?

The Leadership Academy for the Deaf and Hard of Hearing (in our own Deaf-friendly version) will be ready for those interested in advocacy in September. It would be a big plus for those who need more confidence at any level of leadership for the Deaf and Hard of Hearing communities of Utah. The main motivational speaker, from the Deaf President Now Team, will inaugurate the program. (There will be a one-day orientation in August to prepare for the year of mind-powering experiences.) I will be behind the scene conducting the training with support from Vicky Clayson, the coordinator of PPM. Boarding and meals will be taken care of. The Utah Association for the Deaf and Utah Community Center of the Deaf and Hard of Hearing are the co-hosts of the Leadership Academy Training.


