Deaf School Burns in Russia

State flags all around Russia's North Caucasian republic of Dagestan flew at half-mast as the republic's State Council, or the parliament, declared April 11 the Day of Mourning for the victims of fire in Makhachkala's boarding school for deaf children.

The fire at the boarding school killed 28 children and injured 109, of whom 22 are being treated in resuscitation units and 34 more suffer from more or less grave injuries.

Rescue efforts at the school in Makhachkala were slowed since each of the children had to be awakened individually because they could not hear alarms, NTV television reported.

Russian President Vladimir Putin has sent a message of condolences to Chairman of the Dagestani State Council Magomedali Magomedov, in which he wrote the Russian leadership would do everything possible to help the families of the victims.

Makhachkala is located near the Caspian Sea about 950 miles southeast of Moscow.

The UAD Board has agreed to donate money if the NAD is successful in establishing a fund to help the victims.




Ask yourself "What does teamwork mean to you?"

RIT/NTID's Robert Davila Retires

After seven years of dedicated service, Dr. Robert R. Davila, the first RIT vice president for NTID, is retiring June 30.

Davila, 70, has served as the first deaf CEO of NTID since 1996. Dr. Simone said a national search has begun for Davila's successor. "In my judgement, it will not be possible to find the equal of Bob Davila in all of this brilliant dimensions. Bob will be greatly missed, but he has made an impact at NTID that will be felt long after his retirement."

Davila's plan for retirement mirrors his career - to continue his unwavering commitment to disability advocacy. He has been appointed by President George W. Bush to serve on the National Council on Disability, a 15-member group that advises the president and Congress on matters affecting the education, rehabilitation, employment, and independent status of the country's 52 million people with disabilities. Davila is also the first person invited to sit in the Jerry C. Lee Chair of Studies in Technology and the Adult Learner at National University in California.

Deaf Rally Succeeds in New Mexico

Many deaf rallies do not achieve the desired results. Some do - the most memorable one was Gallaudet's Deaf President Now rally.

The one in New Mexico succeeded. DEAFDIGEST last week reported that the deaf people were upset over a hearing person, knowing no sign language, being appointed as the Executive Director of the state commission for the deaf and hard of hearing.

Well, it took much political see-sawing back and forth but the politically-appointed executive director resigned and the new replacement is Tom Dillon, a deaf man who very certainly knows sign language.

All in fairness, the ousted executive director knows finger spelling but that was it. And the governor involved, Bill Richardson, is not aware of the existence of New Mexico School for the Deaf right in Santa Fe. (Note: Tom Dillon was elected as the NAD Treasurer last summer during the NAD Conference.)

Fight the Bite! Don't Give Mosquitoes a Chance

Reduce Your Risk of West Nile Virus During Outdoor Activity

Protect at Dusk and Dawn

That is when mosquitoes that carry the virus are most active, so take precautions to prevent mosquito bites.

Use Repellent With DEET

- * Use mosquito repellents that contain DEET (N, N-diethyl-m-toluamide) when doing any outdoor activity. (Follow the label instructions carefully).
- * For adults, use repellents containing DEET at 30-35% concentration.
- * For children 2-12, use repellents containing 10% or less DEET. Do not use on children under the age of 2.

Take Cover

Wear protective clothing like long-sleeved shirts and long pants while outdoors.

Remove Standing Water

Drain standing water, since that's where mosquitoes lay eggs. This includes tires, cans, puddles, barrels, etc.

Repair Screens

Make sure screen doors and window screens are in good condition. Use mosquito netting when sleeping outdoors or in an unscreened structure and to protect small babies any time.

Remove Standing Water

Eliminate standing water sources around housing areas (i.e., water in old tires, cans, birdbaths, poorly kept swimming pools, etc.).

Cut Grass and Weeds

Keep weeds and tall grass cut short; adult mosquitoes look for these shady places to rest during the hot daylight hours.

Clean and Repair

Clean out leaf-clogged gutters and repair leaky faucets and sprinklers.

The West Nile virus is rare, but if you have symptoms including high fever, severe headache and stiff neck, contact your health care provider immediately. Though anyone can be infected and become ill, severe illness or death is more common in people over age 50. For more information, visit www.health.utah.gov.

Deaf Education in a Fish Bowl

Battles about Deaf Education has gone for years and
years. I have often wondered if it started at the Milan
Conference more than 120 years ago or in the beginning
of our youths?

The Deaf and hearing people have different ideas about how education should be developed for the Deaf and Hard of Hearing children. In the old days, it was a "one size fits all" instead of looking into different styles of education in the classrooms, looking into whether the Deaf and Hard of Hearing benefits more from the sign language or oral methods to develop better learning techniques.

My perspective is like a fish in a bowl. It is either that I am a fish swimming inside a small bowl (going in circles) doing the same thing over and over or that I am a person looking at a fish inside the bowl going in circles. Which one should I be? It is almost the same as deciding which mode of communication values is the best for Deaf and Hard of Hearing students or what kind of Educational Presentation is best for the Deaf and Hard of Hearing students. Why am I pointing at the mode of communication as opposed to educational presentations? Don't we all agree that using the right mode of communication will make education more accessible to Deaf and Hard of Hearing student's learning growth? How can they learn if they are restricted to certain modes of communication that are not designed for their needs? Will they become successful people after High School?

Should we decide which mode of communications fits the child? Should we let the child choose which mode of communication he wants? There is a famous quote in the Bible, it might sounds strange but let me quote, "If we train a child the way he should go, when he gets old, he will not depart from it". I have thought of this quote to be so true about little ones. If we are not careful in what we teach, train, give the child with all the knowledge he needs

with appropriate modes of communications and appropriate educational presentations, especially to Deaf and Hard of Hearing children, the child will think he is a failure because he was placed in a different or "wrong" environment. We will have to guess who to blame. We tend to point fingers at the parents. Should we change our way of thinking? Maybe we should blame ourselves, deaf people? Should we be more involved in the classrooms where Deaf and Hard of Hearing students are? Should we stop swimming in circles in a glass bowl like a fish? Should we become the person looking at the fish bowl? Should we stop pointing fingers at the parents and the school administrators?

There are many "shoulds". We need to stop and think "How are we going to make a better education for the Deaf and Hard of Hearing?"


It is US. We have been there. We know the feelings of being frustrated. We know what we really want. We know what things we wish should have happened in school when we were students. Should we stop being like a fish in the glass bowl or outside looking in? How can we do that?

Sorenson Launches VRS

SALT LAKE CITY, Utah (April 22, 2003)-Sorenson Media(tm) today announced Sorenson VRS(tm), a free video relay service for the 28 million deaf and hard-of-hearing Americans. Once a Serenson VRS account has been established at www.sorensonvrs.com, both deaf and hard-of-hearing users can place video relay calls to family, friends, and business associates through a certified American Sign Language (ASL) interpreter and broadband Internet connection. The call is placed using the Sorenson VP-100(tm) videophone appliance and a TV or using a personal computer with Sorenson EnVision® SL video relay software or Microsoft® NetMeeting® and a Web camera.

The Sorenson VRS Call Center intelligently routes the incoming video relay calls to an available ASL interpreter, who has been professionally trained to handle the calls. The interpreter then contacts the hearing user via a standard phone line and relays the conversation between the two parties. Sorenson VRS captures the facial expressions, gestures, and emotions that are so vital in sign language communication. Hearing users who want to place a video relay call through a standard telephone line to a deaf or hard-of-hearing user can access Sorenson VRS by calling toll free (866) FAST-VRS or (866) 327-8877 and giving the contact information (i.e. name, videophone number, or IP address) to the video relay interpreter. Sorenson VRS takes care of the rest by routing the call with the user's preferences through the Sorenson VRS Call Center to a certified interpreting agent. 
