UAD Treasurer Passes Away



Peter M. Green, a long time UAD treasurer and UAD Bookstore manager, passed away May 25, 2003, following a short illness. He was 69.

Pete was truly a dedicated UAD member, serving in various capacities; it would be

difficult to find another person to do all that he has done. He became a member of UAD when he was 18, and had served as a board member since 1972 and as treasurer since 1987. He also had supervised the UAD Bookstore since 1987, becoming manager in 2000.

In addition, he served other organizations in various capacities - Utah Community Center for the Deaf and Hard of Hearing as an advisory committee member; National Association for the Deaf as convention chairman in 1986; National Association for the Deaf as a board member, 1976 to 1980; USD Alumni Reunion as chairman, 1978 and 1984, to name a few.

He worked for Midwest Service and Supply for 33 years and retired from US Bureau of Land Management in 1998. He is survived by his wife, Sally, sons Marlin, Irwin and Darin and their spouses, nine grandchildren and a great-granddaughter.

His wishes are that donations be made to the UAD in lieu of flowers.

USDB Institutional Council Member's Report

As a representative of the UAD on the Institutional Council of the Utah Schools for the Deaf and the Blind, from time to time it is necessary for me to make a brief report to the members.

First, let me tell you that there is a very friendly attitude among the staff at the main campus at Ogden. People are actually trying to learn a bit of sign language, which eases communication. Although there is still an oral approach working in some classes--especially those where some children have received the implant device--the old bitter warfare between oral and ASL advocates is mostly quiet. Of course, people have their philosophies, but there is no longer open fighting.

As to the implant: Technology has made considerable improvements in the device, and while there are those (I have met them) who wear it and say it helps, there are also those who have discarded it as a useless nuisance (40 to 50 thousand dollars down the drain!). So it is a significant risk that must be carefully evaluated before parents would hang one on a child who is deaf, and quite a different matter if the child is hard of hearing. The USDB has some experts who can advise parents or deaf adults who are thinking about implants.

This year's figures on numbers of students (including deaf, deaf-blind, blind, and children with multiple disabilities):

Total, statewide: 2296.

Counties with the largest number of students:

Alpine, 180; Davis, 249; Granite, 360; Jordan, 259; Salt Lake, 150; Weber, 159.

Counties with the smallest number of students:

Beaver, 4; Garfield, 2; Kane, 3; Tintic, 1; Wayne, 1.

Dagget and Piute are listed as having none.

The rest of the students are scattered widely throughout the state, making it extremely difficult to provide services such as teachers, audiologists, interpreters and interveners.

It should be of interest to the deaf community that USDB is committed to developing a strong interpreting program under Jean Thomas. A continuing problem is that as soon as she gets interpreters trained, many move on to where the pay is better in school districts or private companies. While it is frustrating for Jean and USDB to lose them, the spread of interpreters into public schools has to be helpful to deaf children in the long run. We just hope that the Level One interpreters continue their training and advance to Level Two and Three.

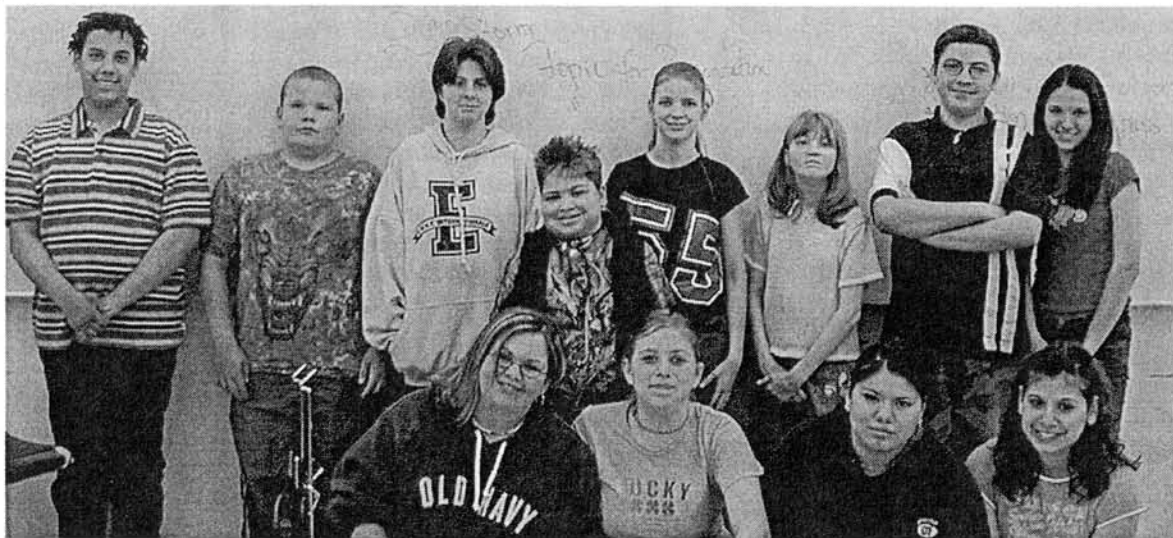
Jr. UAD

Dr. I. King Jordan to Keynote Weber State University's 5th Annual Diversity Conference

Gallaudet University president I. King Jordan has accepted an invitation to give the keynote speech at Weber State University's 5th Annual Diversity Conference on October 3rd. The theme of the conference is "Diversity at Work".

Dr. Jordan is known nationally and internationally for his powerful advocacy of deaf and severely hard-of-hearing students. He is the eighth president of Gallaudet and the first deaf person to hold the office in its 139 year history. Since taking office after the world famous student rebellion in March of 1988 that protested the appointment of a hearing person as president, Dr. Jordan has provided outstanding leadership to the university despite some naysayers who did not think a "deaf person was ready for such a responsibility."

Dr. Jordan and his wife, Linda, have two children--daughter Heidi and son, King. They reside in the historic "House One" on the Gallaudet campus. There is in Utah a Beehive Chapter of the Gallaudet University Alumni Association. Chapter members will be delighted to welcome Dr. Jordan and Linda, and probably will turn out in force to "see" his keynote speech.

Andrew J. Lange Elected As NAD President

The Board of Directors of the National Association of the Deaf (NAD) elected Andrew J. "Andy" Lange president at their May 5, 2003 meeting in Silver Spring, Maryland, filling the vacancy resulting from the resignation of former President Kent Kennedy. Lange will serve out the remainder of Kennedy's term ending at the Biennial NAD Conference in Kansas City in July 2004.

Andrew J. Lange's professional career spans more than thirteen years in the telecommunications industry. He recently became Chief Operating Officer with Handscomm, Inc., in Sacramento, California. Prior to this, Lange was Senior Government Account Executive with Sprint Corporation, and he has also held positions at CSD and AT&T.

Lange's community service spans the local, state, and national level- most recently as Region III Representative on the NAD Board of Directors. He currently serves as President of the Gallaudet University Alumni Association. Previously he was Board Member (1991-94) and then President (1995-97) of the Georgia Association of the Deaf. An active member of the Association of Late Deafened Adults as well as TDI, he served as a member of the 2001 TDI national conference committee. Lange was also Chair of the U.S. Deaf Ski and Snowboard Association qualifying competitions in 2002.

Lange graduated from Gallaudet University in 1983 with a Bachelor of Science degree in Business Administration and Data Processing. In 1995, he received a Master's degree in Organizational Management from the University of Phoenix.

Lange has a progressive hearing loss that began at the age of 14. He and his siblings are the third generation of deaf members that include grandparents, parents, aunts, uncles, and cousins. Lange and his wife, Sue, have a 13-year-old son, Eric. This summer, they will be relocating from Atlanta, Georgia to the Sacramento, California area.

USADB Qualifying Event in Fremont, CA

The first round of qualifying events for the men and women's national basketball teams will be held July 23-26, 2003 at the California School for the Deaf in Fremont, CA. This will be the first of several events leading to the final selection of the National Men and Women's Teams to represent the USA at the Summer Deaflympics in January 2005 in Melbourne, Australia.

David Hamilton of Phoenix, AZ and Barbara Hyde of Santa Monica, CA will conduct this qualifying event under the auspices of USA Deaf Basketball, Inc. (USADB)

David and Barb are both former Deaflympian Gold medalists and bring with them many years of basketball training, experience and knowledge.

All applicants must meet the CISS (international) requirement of a 55 dB hearing loss or greater in the better ear. Applicants who have never participated in international deaf competition must submit an audiogram from a trained and state licensed audiologist. All applicants will be required to submit medical certification from their physician attesting to their physical condition along with documents covering the results of a complete physical examination including bloodwork. The physical examination must be less than 6 months old and must be signed by the physician conducting the examination. All applicants must have their own health insurance.

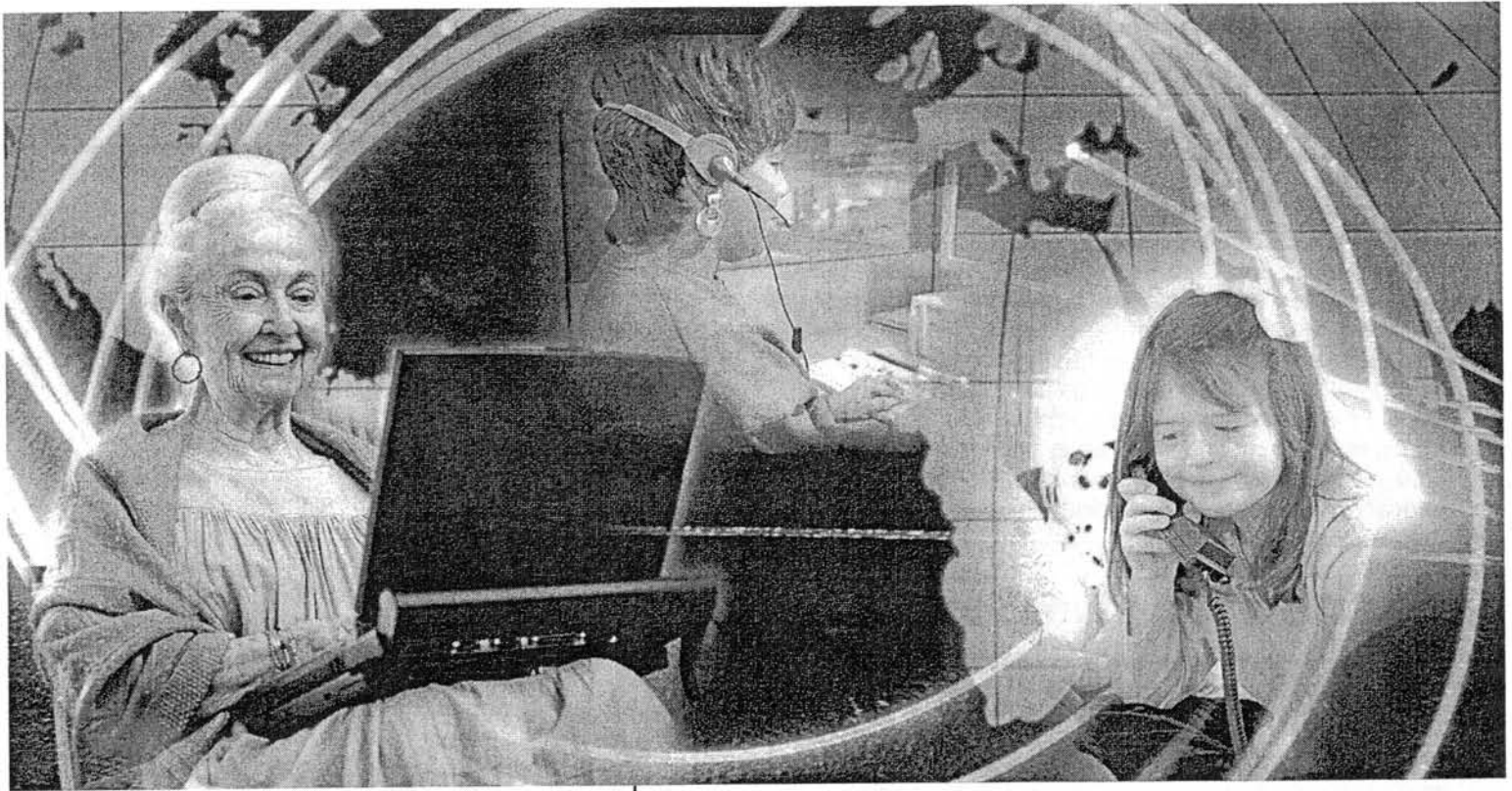

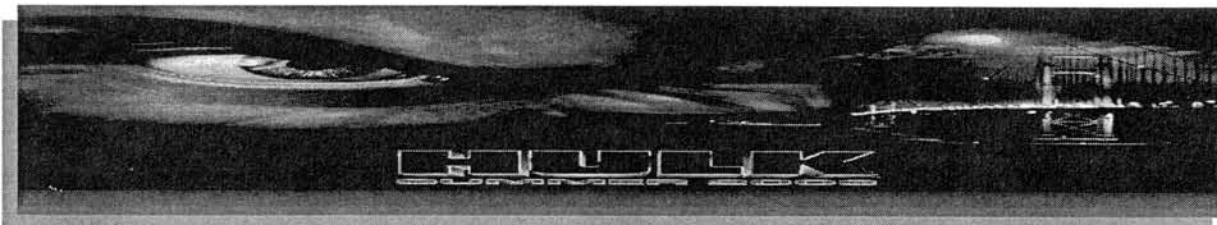
