The General Election for Utah offices, Congress offices and President/Vice-President of America will be held on November 2, 2004 on Tuesday.

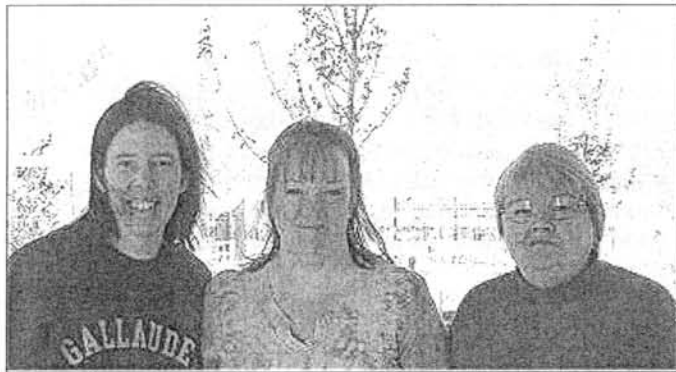
Voter registration is valid for life, unless you *Move, *Change your name, or *Wish to affiliate with a different party. To change your voter registration status for any of the above reasons, simply fill out a new voter registration form.

Voter registration forms must be postmarked at least 20 days before an election in order to vote in that election; or In-person Deadline: You may register in person at the County Clerk's Office until the 8th day before the election.

The Utah Voter Registration form is attached to this Bulletin.

President's Message

October 4 is a bittersweet anniversary when I will be remembering the accidental death of a business partner, Jim Messenger, and also the day the UCCDHH was renamed as the Robert G. Sanderson Community Center for the Deaf and Hard of Hearing. Life is full of ups and downs and it's the highs that make it worth being patient during the lows.

Here are some highs:

~ Robert Sanderson has found a way to share important information about deaf and hard of hearing people who struggle to communicate when arrested or in jail. He gives the news to the chief of police in Roy, who then forwards it to all police stations in Utah. This will educate our police on the importance of meeting deaf and hard of hearing people's needs of communication.

~ The Popcorn Coalition will be meeting in October with the HUD representative from SLC and a owner of 2 assisted living apartments in SLC to discuss a central location for deaf and hard of hearing senior citizens.

~ Jim Christian, Associate Producer for "Music and the Spoken Word", the weekly television and radio broadcast of the Mormon Tabernacle Choir, discovered that UAD is hosting the 9th Annual Western Academic Bowl. In recognition of this event, the Tabernacle Choir is interested in presenting a special, fully signed broadcast on Sunday, February 20th, 2005, with 8 choral signers onstage as well as interpreters throughout the audience. This event would be open to all members whether deaf, hard of hearing or hearing.

~ The Popcorn Coalition will be meeting with representatives from the Utah Department of Public Safety to discuss a project. They recently received funds from a Bioterrorism Grant to address the needs of special populations. They are now working with the Utah Department of Health to gather information on the best way to notify such people during emergencies and will meet with us in October or November.

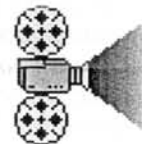

Online Survey on Utah TV News Captions

The Popcorn Coalition does more than promote open caption movies - though that's what pulled us together in the first place. We're very concerned about the accessibility of the local news programs. National news is well captioned almost every time it is on, but the local news - well . . . you know how that is.

And that's what we want to know! How do you feel about the local TV news programs on ABC, CBS, NBC, and FOX? Would you be willing to tell us on a short survey form?

We want to have some general statistics about how D/deaf, hard of hearing and late-deafened people feel about the accessibility of each TV station. That will give us more credibility as we contact the stations about working with us to improve their captioning. Our hope is to open the door for a discussion about captioning local emergencies. We want the guidelines to be in place before the next emergency happens.

Please go to www.uad.org and click on "Utah TV News ~ Feedback" in the left frame and complete the survey. Then bookmark the site on your computer so you can easily return to it when things happen in the future that you'd like us or the stations to know about.

We expect some of the stations will want us to forward compliments and complaints as soon as we get them, and other stations will want them sent once a month. Your future comments will be forwarded to the stations, but the main point is that the Popcorn Coalition wants to know how you like your news.

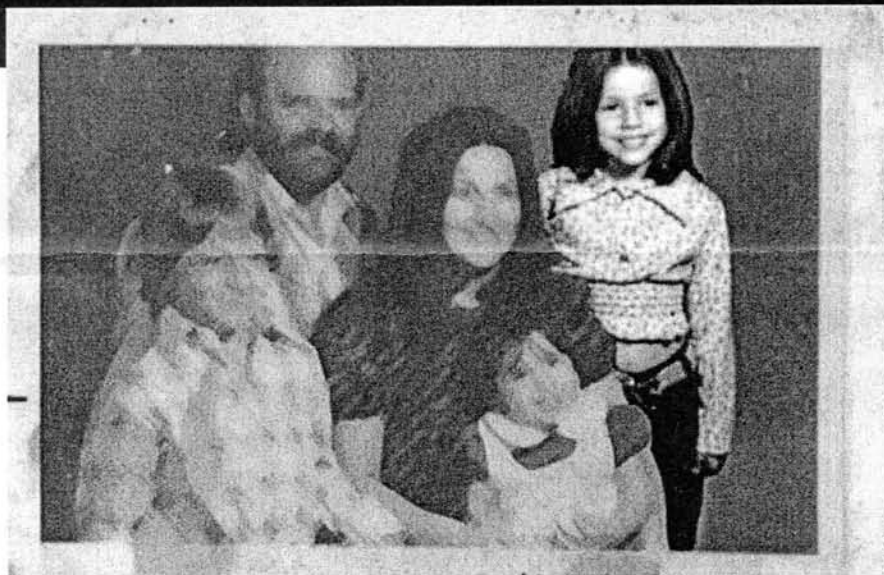

You can use this form to:

- register to vote in Utah.
- change your name or address on your voter registration record.
- register with a party or change your party affiliation.

To register to vote in Utah, you must:

- be a citizen of the United States.
- have resided in Utah at least 30 days immediately before the next election.
- be at least 18 years old on or before the next election.
- first time voters must include a copy of a valid form of photo identification or proof of residence (or present it at the polls).

Deadline for Submitting this Form

This form must be postmarked at least 20 days before an election to be eligible to vote in that election.

Mail-In Registration Instructions

- Complete all required information in the form below. Boxes 1, 6 and 9 are optional.
- If you previously registered to vote with a different name or address, complete box 14.
- Read the voter declaration in box 15 and sign in the box below it.
- Mail the form to your county clerk's office. The address of your county clerk is listed on the back of this form.
- For boxes 10 and 11, one or the other must be completed. If you do not have a driver license or a state identification card, please write "none" in box 11 and fill in the last four digits of your social security number in box 10.

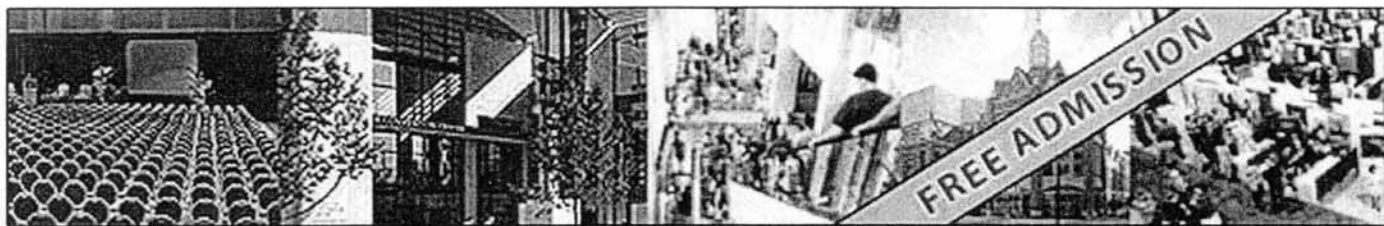

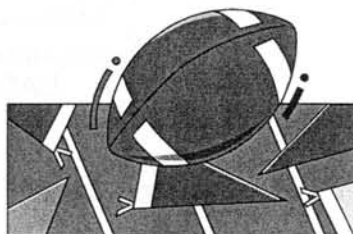
