

Ticket to Work

If you receive SSI (Supplemental Security Income) or SSDI (Social Security Disability Insurance) benefits from Social Security, you will receive a Ticket to Work soon in the mail. The Ticket to Work invites you to try to work. Ticket to Work does not mean you must work. It does not mean you will lose your benefits. It means you can contact Vocational Rehabilitation or any other Employment Network to assist you to prepare to work or to help you find employment. If you have questions how going to work will affect your benefits, you can make an appointment with a benefits specialist. Benefits Specialists can assist you to understand how going to work will affect your Social Security benefits. They can meet you at your home or in an office at Workforce Services near you or at a Vocational Rehabilitation office near you. For a meeting with a Benefits Specialist, call Margot Dana at 801-887-9500 to request an appointment. Please tell her you want an interpreter for the meeting.

You can contact the Vocational Rehabilitation office to meet with a VR counselor who works with Deaf and Hard of Hearing people. The VR counselor can explain the Ticket to Work and assist you to find a job.

September 2003



JMS Charter Meets Federal and State Goals

Utah charter schools scored a perfect 12 for 12 under new federal performance standards that recently dinged a third of the state's public schools.

JMS met their goals for student participation and achievement on state tests in language arts and math. JMS met the academic achievement goals under No Child Left Behind.

JMS's success along with other charter schools's successes in Utah could build political momentum to expand school choice during the 2004 legislative session,

which begins next month. Lawmakers already have filed bills to loosen the state's charter-school law and authorize tax breaks for parents who pay private-school tuition.

The AYP reports are a cornerstone of No Child Left Behind's accountability provisions, which require public schools to improve academic achievement of all ethnic, language, disability and socioeconomic groups. To show whether they are indeed improving, schools had to report 2002 and 2003 percentages of kids who passed and their rates of participation on state tests.

Charter schools are taxpayer-funded public schools. They are empowered to use innovative teaching methods, but they must adhere to most of the same financial and educational standards as other public schools.

Nineteen charter schools have opened in Utah since the Legislature authorized them in 1998. Twelve of them are old enough to be subject to AYP this year.

Charters have another advantage: active parents.
"It's hard to measure that our teaching technique is

why we've done so well, but I believe it is one of the reasons," said Eric Smith, president of the school board at Lindon-based Timpanogos Academy, a K-6 charter.

"Another is that charters are successful because the children are children of parents who really care about their education."


