#### Satellite Center in St. George

Thanks to the 2004 Utah legislative session, deaf and hard of hearing people in the St. George area will have a Deaf/Hard of Hearing Center, a satellite office of the Sanderson Community Center for the Deaf. Plans are for the new center to be up and running by July of this year.

Marilyn Call, director of SCCDHH, was instrumental in lobbying for the Center. Senator William Hickman and Representative David Clark were the lead legislators in guiding a bill to fund the center. Despite the slow economy, making it a difficult year to obtain new funds, these two legislators made it happen. The legislators were dedicated to getting this new money because of good lobbying by deaf and hard of hearing people in St. George. Von Jones organized and led the lobbying efforts.

With no location to hold classes in the last year or so, Mari Moss and Julie McCleave worked from their homes organizing and finding locations for classes and meetings. The satellite office has been operating informally for the past one year, offering classes and workshops for deaf and hard of hearing people in the St. George area. Classes included CPR, computers, Mexican cooking, budgeting, anger management, living with hearing loss, ASL classes, support groups, sewing, visiting historical sites, and speech reading; with many more on the calendar or in the planning stages.

Now all that will change. The community will now have a place to call their own. Marilyn Call is currently looking for a location for the satellite center. Hands waving in the air!

#### **UAD Launches New Service**



#### President's Message

#1.

Phone Line + TTY: Your phone link is your connection to 9-1-1. If you have an emergency of ANY KIND, simply dial 9-1-1. Even if 911 does not answer with a TTY, they will send an emergency service to your house.

This alone is worth keeping a phone line connection active. **VideoPhone:** Video Relay services do NOT want you to use them for 9-1-1 emergency calls. Their brochures, websites, advertisements make this clear.

#2.

Phone Line + TTY: If the power to your house is cut, your TTY (with batteries) and a phone line is your link to the outside world. You can call 9-1-1, utility companies, government agencies, etc. and find out what is going on.

**VideoPhone:** If the power to your house is cut, VideoPhone will not work. You will have to do a lot of driving or use leg-power to find out what is going on.

#3.

Phone Line + TTY: You can call the relay services 24 hours a day, 7 days a week.

VideoPhone: None of the Video Relay services are operating at 24 hours a day, 7 days a week. If your heater stops working at 3 a.m. in the winter and it is very cold, you will not be able to call an emergency repair service.

#4.

Phone Line + TTY: All deaf people have TTYs. You can call anyone with your own TTY and a phone line.

**VideoPhone:** Only a few deaf people have VideoPhone today. You could lose a friend!

Recently, a friend was very upset because he was not able to call his friend who threw away his TTY and phone line and only has VideoPhone.

Keep your TTY and phone line!

to push for an amendment to the Telecommunications Relay Service bill that was passed a few years ago. The amendment would say that any relay service bidding for operations in Utah and obtaining it would in effect be required to set up shop in Utah.

- Went on record as supporting Dr. Lee Robinson to continue as superintendent, and not to replace him with any person from the current USDB staff.
- Went on record as supporting the Jean Massieu School program and its philosophy of using ASL and bi-bi education.
- Authorized the purchase 300 of paper plates, napkins and plastic forks to replace what was taken out of Center supply at the time of "Open Your Hearts" fundraiser.
- by Deaf Heritage and Library Cultural. The Leadership Fund will be used to defray costs associated with leadership training and related activities. The costs will be retroactive to the date that the funds were turned over to UAD: February 20, 2003. The amount turned over to the UAD totals \$2,813.48. The UAD has defrayed the cost of LADHH in 2003, and these costs are to be deducted from the total amount. Remaining amount after deducting 2003 expenses is \$2114.43.

#### Relay Utah

The Public Service Commission is busy at work with
some new and exciting projects and services for Relay
Utah.

About 40 Utahns have been participating in a trial of a new product and service. This product is called the CapTel, which is a Voice Carry-Over, amplified, and captioned telephone all in one. It is a product manufactured by Ultratec and functions like a regular telephone. The user dials the phone which then automatically connects to the captioning service. Just like a television with captioning, the CapTel provides the user with both the voice and the text transcription nearly simultaneously. The captioning service involves the use of voice recognition technology that eliminates waiting time caused by typing during standard relay calls. The lag time is so short that the voice user is unaware of the use of relay.

Currently there is a waiting list for the CapTel. In order to obtain one after the trial period which runs into April, then you must fill out an application with the Public Service Commission. An Audiologist must complete a form, and the applicant must have a hearing loss of 60 decibels or more with 70% speech discrimination or less. The Commission and an advertising company, Penna Powers Brian Haynes, have been working hard to get the word out about the relay service. Three commercials are now airing on Channels 4 and 13. Keep on the lookout for the one- minute spots about 7-1-1, Relay Utah, and Voice-Carry Over. The stations are also running 15-second spots of all three commercials as Public Service Announcements

The contract with Sprint and Relay Utah expires in January, 2005. A Request for Proposals (RFP) is due to be released in early April. TRS providers will be submitting their proposals in July, so the selection committee will be busy this summer collecting references, making text calls, and evaluating the vendors' responses. Stay tuned for any news or changes this fall for Relay Utah.

### Board of Education dismisses USDB leader

Scrutinized for his financial budgeting decisions, Lee Robinson, superintendent of the Utah Schools for the Deaf and the Blind in Ogden, will soon be looking for a new job.

The state Board of Education voted unanimously Friday to dissolve Robinson's job position, restructure and rename USDB leadership, and provide more oversight to the school, especially regarding its finances.

Robinson has the opportunity to reapply for the school's new leadership position. He has been superintendent since August 1994. The board plans to advertise the position immediately, with the search ending in 90 days.

The board's decision was in response to an audit by the legislative auditor general, who recommended changes to USDB management structure. The decision also followed a series of meetings of the board's audit committee.

The legislative audit alleged Robinson misrepresented the school's financial condition during budget cuts in 2002. Specifically under scrutiny was \$850,000 of 2002 USDB funding that could have been used to hire teachers. However, the school left jobs vacant.

Robinson said in earlier interviews his financial decisions were simply conservative budgeting practices in which he chose to wait until he knew how much funding was coming in, then applied it to the next year's budget, instead of spending the money immediately.

The Legislative Auditor General's Office said neither mismanagement nor malfeasance played a role in the audit concerns

However, the board unanimously voted Friday to issue a letter of reprimand to Robinson, and also to restructure USDB administration.

USDB will be supervised by Carl Wilson, Director of At Risk and Special Education Services, in the state office.

The position of USDB superintendent will be retitled Principal Academic and Operations Officer. This person will be under the direct authority of the Director (Wilson).

The USDB Finance Director, currently Vicki Bell, will be under direct authority of the state office finance director. The USDB position will be moved, either part-time or possibly full-time, from the USDB site in Ogden to the state office site in Salt Lake City.

#### **Tantrums? What Tantrums?**

Some parents think they have found the answer for taming the tantrums of the terrible 2s. Of course, there will never be a cure-all for every outburst, but some say an effective antidote lies in communication — well before the children are able to speak.

Tyber Buchheit wants some juice. Without making a sound he lets his mother know exactly what he's after. Just under 2, he is starting to verbally articulate what he wants, but in the past year simple hand movements have been doing the job.

Kaylin Olsen, family consumer human development instructor at Utah State University, said babies start to make the communication and language connection before they can speak. Using that skill as soon as they develop it makes for less frustration.

"When they realize they can get the things they want through signing they want to sign more," said Olsen.

Olsen suggests parents start signing with babies around 6 months old — near the time they start pointing and gesturing. Then just work the signs in with everyday natural interactions such as eating, dressing and playing.

Olsen said a popular parental concern is whether teaching signs will delay a baby's speech. If he is already getting the message across successfully, what is the rush in learning to talk?

"Babies have an intrinsic want to be around and use words," Olsen said. "If anything it encourages a language development earlier — seeing that they can get what they want through communication."

It generally works like this. Parent teaches baby the sign along with saying the word; baby uses sign; then baby uses both sign and word; then baby drops the sign and uses the word.

Signing just introduces babies to language earlier. Stephanie Flake has two children, Sierra and Landon. Landon was signed to; Sierra wasn't. She is now convinced that the culprit for the terrible 2s is lack of communication.

Landon, well into his 2s, is her youngest. Along with a marked difference in tantrums and frustration in comparison with Sierra at that age, Landon's language ability is more complex, his mother says.
