"Open Your Hearts" Fundraiser a ROARING Success!

Over 200 people attended the "Open Your Hearts" potluck luncheon and fund-raiser. \$3,675.10 was raised through donations of cash and checks, to assist the National Association for the Deaf in fighting the weakening of the Americans with Disabilities Act. And to think our goal was to raise \$1,500! The money collected more than doubled the goal.



At each of the four regional conferences held last fall, state associations were challenged to conduct fundraising. Utah is currently leading all 50 state associations with the most money raised. This speaks well of our Utah people, who opened their hearts and their wallets to contribute to the NAD effort.

Dennis Platt was emcee, with speakers coming onstage talk about National Association for the Deaf and its effort to prevent the weakening of the Americans with Disabilities Act. Speakers included former NAD presidents, Larry Forestal and Robert Sanderson, Region IV representatives, Leon Curtis from Washington State and Norma Lea Chrismon from Nevada; Eli McCowan and Nancy O'Brien, UAD representatives to Region IV last fall; Rollin Jones, LaVonne Conway and Bev Allred, LADHH (Leadership Academy for the Deaf and Hard of Hearing) students.



New Bachelor of Arts Degree in Speech & Hearing Science

The new BA includes an Emphasis in teaching American Sign Language in the Department of Communication Sciences & Disorders at the University of Utah in Salt Lake City, Utah.

In 1994 the Utah Legislature approved the official recognition of ASL as a language. In addition, the legislature mandated that (1) ASL shall be accorded equal status with other linguistic systems in the state's public and higher education systems, and (2) the State Board of Education, in consultation with the state's school districts and the Utah deaf community, shall develop and implement policies and procedures for the teaching of ASL in the state's public education systems.

In 1997 the Emphasis in Teaching American Sign Language program was established under the Department of Communication Sciences and Disorders at the University of Utah.

The program objective is to prepare college students to teach ASL in the Utah public schools where ASL satisfies foreign language requirements.

In February 2003 the departmental faculty approved the revised Emphasis in Teaching ASL curriculum and state licensure of ASL teachers in the Utah public schools.

The Emphasis in Teaching ASL program includes sequential language course requirements in ASL as prerequisites. It also requires sixty-three (63) undergraduate credits in the major area of study and core education prior to graduation. Teaching ASL courses include the culture and history of American deaf people, linguistic aspects of ASL, methods of teaching, deaf literature, and student teaching opportunities.

Utah & Idaho Superintendents Fight to Keep Jobs

Dr Lee Robinson, superintendent of Utah Schools for the Deaf and Blind, came under withering attack by legislative leaders for misrepresenting his agency's finances nearly two years ago in testimony to a joint House-Senate budget committee. Robinson acknowledged making wrong claims but insisted it wasn't deliberate.

The Utah Schools for the Deaf and the Blind kept an \$850,000 fund balance in a conservative budget strategy that would prevent the school from going in the red as it did in the early 1990s — not because of ill motives, the school's chief said Friday.

Superintendent Lee Robinson defended his actions before a State Board of Education committee, put in place, at lawmakers' behest, to determine whether Robinson should keep the job he's had for more than 10 years. The action follows an audit showing the chief let \$850,000 sit unused instead of hiring needed teachers, among other issues.

Basically, the school would include the carryover in each following year's budget to make sure it followed state instruction and didn't overspend, Robinson said.

"These carryover funds are committed to staff, projects ... the following year," said Robinson, who provided the board a 10-page response and a stack of other information, from parent satisfaction surveys to school accomplishments under his tenure.

"Given my experience, my background, I guess the only thing that bothers me is . . . I think some people have questioned my motives as to whether I was really interested in providing services to children. I assure you, that has always been my top priority."

A hearing officer is recommending the reinstatement of Angel Ramos as superintendent of the Idaho School for the Deaf and Blind in Gooding.

Charles McDevitt, a former chief justice of the Idaho Supreme Court, filed his recommendation Thursday following last month's hearing with the State Board of Education and Ramos' attorney.

In addition to recommending reinstatement, McDevitt said the board should reaffirm the policy Ramos was hired to carry out -- to transform the institution's emphasis from custodial to educational.

However, the Board of Education could ask McDevitt to reconsider his findings, and will ultimately have the final say on whether Ramos returns to work.

If it rejects McDevitt's recommendation, Ramos could challenge the process in court. His attorney, Cynthia Woolley, said no decision would be made until the board acts.

A New Way to Caption Meetings

Two national court reporting/closed caption firms have advanced technical ability and skill to turn the spoken word into written text in real time via the Internet. With this state of the art technology, if the deaf or hard of hearing needed to sit in on a public or private meeting, they could log onto the Internet, go to a specified web site, and see the live verbatim words that were being spoken as they were actually heard! In certain situations, depending on the type of meeting, the deaf and hard of hearing will also be able to transmit their thoughts and ideas much in the same way one would use "Instant Messaging."

All that is required is for the caption writer to be able to listen via speaker phone to the proposed meeting. With this service the deaf and hard of hearing can now for the first time freely interact in a remote group discussion or conference. In addition, an unedited transcript would be instantly available as well.



In what may prove to be the biggest shift in emergency care of cardiac arrest in 40 years, cities across the country are leading a move away from the familiar practice of using mouth-to-mouth resuscitation.

In its place, the cities are recommending simple chest compressions - pushing down repeatedly on the victim's chest - to mimic a steady heartbeat. The emergency medical directors who are behind the shift say research in Seattle and Richmond, Va., suggests it will save many lives.

Seattle saved more lives by advising compressions alone, and Richmond rescuers arrived to find 10 times more victims (60% vs. 6%) getting lifesaving compressions when not distracted by advice on breathing techniques.

For now, the shift applies primarily to untrained bystanders, the group most likely to reach victims in the first critical minutes. In such emergencies, lives generally are saved or lost within six minutes. The emergency directors agreed that trying to talk 911 callers through mouth-to-mouth procedures was doing more harm than good because it wasted time.

While the heart association would prefer that all adults be trained in CPR so that they can practice their skills before they are faced with a crisis, officials with the association agree that immediately beginning compressions alone is better than waiting even a minute or two to begin CPR. "We strongly support this," says Mike Bell, vice president for emergency cardiovascular care programs. "This gets something done."
