

Utah Legislature and Advocacy, Part II

There are two effective ways to get your representatives' attention "personally". They are Capitol visits and do's and don'ts with a legislator. Call the capitol for their office numbers and also ask for interpreting services which is at their expenses, not yours!

Visiting Capitol Hill

Meeting with a member of Congress or congressional staff is a very effective way to convey a message about a specific legislative issue. Below are some suggestions to consider when planning a visit to a congressional office.

Plan Your Visit carefully:

1. Be clear about what it is you want to achieve.

2. Determine in advance which member or committee staff you need to meet with to achieve your purpose.

Make an Appointment:

1. When attempting to meet with a member, contact the Appointment Secretary/Scheduler.

2. Explain your purpose and who you represent. It is easier for congressional staff to arrange a meeting if they know what you wish to discuss and your relationship to the area or interests represented by the member.

***Don't forget to ask for interpreting services! Call House of Representatives at 801-538-1029. The secretary will arrange for both the Senate and the House of Representatives.

Be Prompt and Patient:

1. When it is time to meet with a member, be punctual and be patient.

2. It is not uncommon for a Congressman or Congresswoman to be late, or to have a meeting interrupted, due to the member's crowded schedule. If interruptions do occur, be flexible. When the opportunity presents itself, continue your meeting with a member staff.

Be Prepared:

1. Whenever possible, bring to the meeting information and materials supporting your position.

2. Members are required to take positions on many

3. In some instances, a member may lack important details about the pros and cons of a particular matter.

4. It is therefore helpful to share with the member information and examples that demonstrate clearly the impact or benefits association with a particular issue or piece of legislation.

Be Political:

1. Members of Congress want to represent the best interests of their district or state. Wherever possible. demonstrate the connection between what you are requesting and the interests of the member's constituently.

2. If possible, describe for the member how you or your group can be of assistance to him/her. Where it is appropriate, remember to ask for a commitment.

Be Responsive:

1. Be prepared to answer questions or provide additional information, in the event the member expresses interest or asks questions.

2. Follow up the meeting with a thank you letter that outlines the different points covered during the meeting, and send along any additional information and materials requested.

Deaf Students May Sue USU

A group of hearing-impaired students is threatening legal action against Utah State University, claiming the school isn't providing enough quality sign-language interpreters, therefore limiting the students' class choices.

Utah State officials say they are trying their best to meet the needs of hearing-impaired students despite a statewide shortage of sign-language interpreters.

"We're doing the best we can," said Diane Baum, director of Utah State's Disability Resource Center.

"Whether we can do it to the level that will satisfy them (the hearing-impaired students) may be a challenge because of the shortage," Baum said.

University officials say they are working toward recruiting more sign-language interpreters.

But hearing-impaired student Jonathan Roberts, 24, of Logan, a senior at Utah State, is tired of excuses.

"They haven't done anything, and it's getting worse," Roberts said. He is leading the students who are considering suing.

About 15 current, former and prospective students who use American Sign Language have retained attorney Dale Boam, of Sandy. He spent nine years as a signlanguage interpreter before entering law school.

Boam alleges Utah State is violating the students' rights under Title II of the Americans with Disabilities Act. as well as Section 504 of the Rehabilitation Act of 1973.

The attorney has sent the university a letter demanding action within 60 days, or the students might file a lawsuit.

"They are not being given access to education because they are not being provided with proper service," Boam said. "We want results, not more talk."

The university employs five sign-language interpreters who are working toward certification.

Utah State also employs seven transcriptionists to sit with hearing-impaired students and type lectures. Students can type questions to the transcriptionists to ask instructors.

However, some hearing-impaired students say a transcriptionist is no replacement for a sign-language interpreter. Further, they say some of the interpreters are below par.

"It's been very frustrating," Roberts said.

Further complicating the issue, most of the signlanguage interpreters and transcriptionists employed by Utah State are full-time students. They generally attend daytime classes and are available to work between their classes during the day, and then in the evenings. That limits the class choices for hearing-impaired students.

"Students are not being provided equitable access," Boam said, adding several students have told him they have had to postpone graduation because of the situation.

Utah State officials say they are working on the situation. The university last month approved a full-time certified sign-language interpreter position, with a \$32,000 salary, plus benefits. To fill the position, the school is about to launch a national search.

Further, the university has approved increasing salary levels of its highest-level sign-language interpreters to be \$1.50 above those working at colleges and universities in the Salt Lake area, who are generally topping out at \$24.50 an hour, Baum said.

Pay for interpreters can range from around \$9 to \$20 per hour, depending on education and skill, and also whether the interpreter works in the public or private sector, according to the Division of Services to the Deaf and Hard of Hearing.

Utah State pays its sign-language interpreters \$11 to \$22 per hour. Most are receiving \$13 per hour, Baum said.
