Do You Know Your Credit History?

Identity theft is a problem all over the United States. The Internet allows many transactions, which used to require meeting in person, to be accomplished over the computer or through the mail; without either side seeing the other parties face. While this makes our lives more convenient, it heightens the risk that someone will use our name, social security number, or other identifying information to rob you: making a purchase, securing a loan or getting a government benefit. The thief gets the benefit and then leaves you with the responsibility to pay the bill. If someone steals your identity it can cost thousands of dollars immediately and thousands more in ruined credit and missed opportunities; and take months, if not years, to clear your name.

How do you know if someone is using your identity? If someone is using your information how do you stop it?

How do you protect yourself?

First, know your credit history. Remember there are at least three different credit reporting companies widely used in today's market; Experian, TransUnion, and Equifax. A copy of your report from one reporting company such as Experian saying you have a clear record it doesn't mean you are clear the reports from the other two companies. Some creditor groups report to one company but not another company. Sometimes, you can have errors on your report because information was reported incorrectly or typed into the report incorrectly. An error or a black make on one report can cost you a loan for your home, or car or cause the variable rates on your credit cards to rise.

Each person in Utah can get a copy of his or her credit history from each of the big three reporting companies by going to one place on the Internet; www.annualcreditreport.com. There are several other websites with very similar names and some call themselves "free report," but the reports are not free! These reports are free one time each year! It takes about 40 minutes to get and print all three reports. The website also explains how to read your reports and how to report errors or identity theft.

If you think someone is using your identity REPORT IT TO THE POLICE! Don't wait. The bank or the other credit agencies will want a copy of the police report.

You can get more information about identity theft from the Federal Trade Commission at www.consumer.gov/idtheft. I recommend this site to everyone; whether you are suspicious of theft or not.

Remember, protect yourself. Don't give out personal information to anyone you do not know, and never over the phone or over the Internet.

Ask the Doctor!

It's a beautiful day with the sun shining – a perfect day for a bike ride!
Bike riding is a lot of fun and a great family activity, but accidents happen. Some of

these injuries are so serious that children and adults die, usually from head injuries. A head injury means a brain injury, which could affect you for the rest of your life. That is why it is so important to wear your bike helmet to protect your head in case you fall down.



Bike helmets are so important that the U.S. Government has created safety standards for them. Look for the sticker on the helmet indicating that it meets the Consumer Product Safety Commission (CPSC) standards. In

order for the bike helmet to be effective,

it needs to be worn correctly on your head, covering your forehead. The straps should be snug enough that you can't pull or twist the helmet around on your head.

It may help to learn hand signals. These are like turn signals and brake lights for bikers. It helps cars and trucks know what you will do next, so they don't run into you.

Knowing the hand signals make you look like a cool bike rider who knows how to ride. Wear your helmet and some bright colored clothing so cars can see you well, and have fun!

NEW FCC RULES on VRS

The Federal Communications Commission (FCC) has adopted rules moving the Video Relay Service (VRS) closer to the goal of providing deaf and hard of hearing persons functionally equivalent access to the nation's telephone system.

The new rules establish, for the first time, mandatory speed of answer requirements for VRS, require VRS to be offered 24 hours a day, seven days a week, and permit VRS providers to be compensated for providing VRS Mail.

The Commission recognized VRS as a form of TRS in March 2000, but waived the speed of answer rules for VRS until January 1, 2006. Speed of answer refers to the amount of time that elapses between receipt of dialing information and the dialing of the requested number.

By Jan. 1, 2006, VRS providers must answer 80 percent of all VRS calls within 180 seconds; by July 1, 2006, VRS providers must answer 80 percent of all VRS calls within 2.5 minutes seconds; and by Jan. 1, 2007, VRS providers must answer 80 percent of all VRS calls within 2 minutes.

Closed Captioning for Television/Cable/Satellite Programs

We are quickly closing in on the year 2006! Why is
that so exciting? Well, according to the FCC, all
television/cable/satellite channels are required by law to
caption 100% of the programs that they carry. However,
since the rules were established, there have been some
changes made, along with some exceptions created. The
following is information to familiarize yourself with the
captioning requirements, and what you can do if you feel
that your captioning needs were not met. The more we
are informed and take action, the better the service will be
for everyone who depends on closed-captioning.

Home videos or video games are not required to provide captioning.

Starting January 1, 1998, all first-run programs must gradually be captioned over an eight-year period. In the year 2006, we should see 100% of these programs with closed-captioning! However, there are some exemptions to this rule. For example, captioning is not required for:

- ~ Programs which are shown between 2 a.m. and 6 a.m. local time;
- ~ Locally produced and distributed non-news programming with no repeat value (e.g., parades and school sports);

- ~ Instructional programming that is locally produced by public television stations for use in grades K-12 and post secondary schools;
- ~ Programs in languages other than English or Spanish:
- ~ Programs shown on new networks for the first four years of the network's operations;
- ~ Public service announcements under 10 minutes, unless they are federally-funded or produced
- ~ Video programming providers with annual gross revenues under \$3 million (although such programmers must pass through video programming that has already been captioned).

Emergency programming, such as severe weather reports, disasters and dangerous community situations, and school closing are to provide captioning regardless of these exemptions.

FILING A COMPLAINT


If you wish to file an informal complaint for failure to provide closed captioning or access to emergency programming, you may send the complaint to the Disabilities Rights Office (DRO), FCC, Consumer Information Bureau, 445 12th Street, SW, Washington, DC 20554. In addition to sending a letter, you may contact the FCC by other reasonable means, including: facsimile transmission, 202-418-2839; phone 202-418-7096 (voice) and 202-418-0189 (TTY); e-mail fccinfo@fcc.gov; audio-cassette recording; and Braille. The complaint should include:

- ~ The name of the video programming distributor against whom the complaint is alleged;
 - ~ The date and time of the alleged violation; and
- ~ Details about the problem so that the distributor may correct or otherwise respond to the complaint.

The FCC's DRO can provide informal dispute resolution to obtain compliance with the rules. However, the Cable Services Bureau (CSB) is responsible for handling formal actions needed to enforce the closed captioning rules.

FCC rules require formal complaints for *violations of* the captioning rules to be sent first to the video program provider before they may be brought to the FCC.

Although you are encouraged to bring formal complaints for *violations of the emergency rules* to the video program provider, you are not required to do so. If you do wish to file a formal complaint for a violation of either the captioning rules or the emergency programming rules, send it to: FCC, Cable Services Bureau, 445 12th Street, SW, Washington, DC 20554; phone 202-418-7096 (voice) and 202-418-7172 (TTY); e-mail CSBINFO@fcc.gov, and fax 202-418-1195. For more information on the FCC's captioning rules and requirements, go to www.fcc.gov/cib/dro, and click on closed captioning.
