Website Offers Health Education in ASL

Westminster, MD-September 26, 2008. The Deaf & Hard of Hearing (D/HoH) community now has a place to learn more about various health topics in their native "tongue" of American Sign Language (ASL).

www.DeafMD.org was launched today for the sole purpose of providing health education in American Sign Language to promote the overall wellness of this vastly underserved population.

Recognizing the need of a trustworthy, unbiased, online health resource that the D/HoH could turn to when they had medical questions, the creators of DeafMD worked in partnership with the Centers for Disease Control and National Institutes for Health to provide this vital information. The information was evaluated by a team of linguists, medical professionals, and educators and translated into ASL.

Visitors to DeafMD can search a list of diseases, illnesses, medical tests, and current news events, with each webpage providing a clear video translation explaining the selected topic.

DeafMD has begun to compile a list of "Deaf-Friendly Doctors" to help the D/HoH community get plugged in to medical professionals in their local area. To be included on this list, the provider listed must be deaf or sign ASL fluently. someone on the provider's office staff must be deaf or sign ASL fluently, or the provider's office must have a video relay service and hire a qualified interpreter for the office visit as required by the American's with Disabilities Act. Specialties added thus far include mental health providers, physical therapists, and primary care physicians, along with many others. More medical professionals will be added and the D/HoH are encouraged to contact DeafMD if they know of a provider who meets the criteria listed of being a "Deaf-Friendly Doctor." DeafMD also has e-news, which allows individuals who register for this free service to be notified by email when new topics are published on the site.

There is no charge to use DeafMD, but DeafMD is dependent upon donations from website visitors to keep it running. "Our mission is to provide clear and concise health information in ASL to promote the overall wellness of the D/HoH community," said Casey Davis, DeafMD Founder. "We would not want to hinder access to this vital information because someone could not afford to pay for it. We hope to benefit the entire Deaf population, regardless of socioeconomic status."

Residents of Chicago, San Francisco, and New York areas can see DeafMD live at upcoming events as part of the DeafNation tour in the fall of 2008. DeafMD also has tentative

plans to participate in the 2009 DeafNation tour, which will be visiting 14 cities across the United States.

NAD Announces Release of Two Mental Health Position Statements

Posted October 3, 2008 The Board of Directors of the National Association of the Deaf (NAD), at its April 2008 meeting, approved a new position statement on Mental Health Services for Deaf Children and a supplementary position statement entitled Culturally Affirmative and Linguistically Accessible Mental Health Services. Both statements, recently posted on the NAD website, were prepared by the Mental Health Subcommittee of the Public Policy Committee. The supplementary statement is intended to be an update to the 2003 NAD Position Statement on Mental Health Services for People who are Deaf and Hard of Hearing.

These documents will provide guidance to state and federal agencies, consumers, state associations, and affiliates on appropriate mental health service delivery for deaf children and adults. In addition, the two documents reflect the belief of the NAD that access to language, namely American Sign Language (ASL), is a basic human right.

"I am proud of the work that this subcommittee did. This subcommittee had top experts in the mental health and deafness field from all over the country," said NAD President Bobbie Beth Scoggins. "Together, they produced two documents that reflect current trends in the field and are a model for all states and service providers. Service delivery for deaf children poses particular challenges that are unique and different from those for deaf adults," she continued. "It is vital that optimal mental health care for deaf children be available in this country."

The Public Policy Committee is chaired by Howard A. Rosenblum, Esq., who has years of experience in mental health law. Liz Hill, LCSW, served as chair of the Mental Health subcommittee, and was recently elected to the NAD Board of Directors. Members of the subcommittee were: Ro bert Baldwin, Sara Bianco, Barry Critchfield, Suzanne Dennis, John Gournaris, Michelle Niehaus, Linda Russell, and Brad Trotter, Melissa Watson, Roger Williams, and Darlene Zangara.


