Obituaries

October 7, 2008 - John Belcher, husband of Sheri (Hanberg) Belcher, died October 7th, Salt Lake City. He was interred in Bridgerland Cemetery, near Roosevelt in the Hanberg family plot over the November 1 weekend.



October 11, 2008 - Dr. John Simonsen of Orem passed away peacefully at the age of 81 years. John graduated from the University of Utah with a Bachelor's degree in Mechanical Engineering, then went on to earn his Master's and PhD from Purdue University. After completing his education, John returned to Provo where he helped start the Mechanical Engineering program at BYU. He taught at BYU until 1975 when

he left BYU for Valtek. He served as vice-president of Engineering at Valtek until his retirement in 1987. Funeral services and interment took place in Provo. Reid Simonsen of Orem was a son.

October 13, 2008 - Elizabeth Clark passed away on at the age of 75 in Michigan. Funeral services and interment took place in Redford Township and Livonia, respectively. Elizabeth was the wife of Rex Clark, formerly of Utah.

- Bertrand Voss passed away in Ogden. In his youth, he competed in track and was a member of the State Champion Medley Relay Team, and graduated from the University of Utah. Bert served in the US Navy on the USS Hornet in the Pacific. Later he served

in the Navy Reserve and retired from the Air Force Reserve. He was an avid Wood Badger and active in the Order of the Arrow; he took two of his sons to the National Jamboree in 1984. He taught at the Utah Schools for the Deaf and the Blind for 35 years. Funeral services were held in Mountain Green.

Bookstore celebrates 25 years

A bit of history here - the bookstore was established in 1983 at the old deaf center in Bountiful. Robert Sanderson is credited with the idea, which he learned from NAD. Valerie Kinney was the business manager for both UAD business and the Bookstore, and was the editor of the UAD Bulletin at the same time. Other managers worked under Peter Green's supervision. When the new deaf center in Taylorsville opened in

1992, Grace Watterson was a bookstore manager for a while. When Grace resigned to work for the deaf center, Peter Green took her place and managed it until his death in May 2003. Valerie Kinney took over the bookstore at that time and recruited volunteers to staff the bookstore. Valerie turned over the management of the bookstore in April 2007 to Adele Sigoda who has continued to this day as bookstore manager.

The bookstore has seen changes through the years — mainly in the sale of TTYs, which gave the bookstore a good source of income. With the advent of videophones, the sale of TTYs declined. Best sellers today are doorbell/phone signalers, alarm clocks and sign language books for ASL classes held at the deaf center.

A first is an auxiliary bookstore set up in St. George, on a six month trial. Faith Bassett, who lives in St. George, is the bookstore manager. There is a sizeable deaf community in this southern area.




