tended, the brainstorming session followed on what to do with this new club's activities in the near future.

The activities may include breakfast, lunch or patio picnic in the summer evening, going to terrific places to see, traveling to stay overnight somewhere else in Utah. Lectures/workshops for women only are also added to the list. Interpreting services shall be included at such places and for the workshops.

The Deaf Senior Women had its first activity on April 17th. The weather was very sunny and cool a perfect spring day! After lunch at Davanza's for some pizza and burgers in Kimball Junction, we went to Kimball Art Center in Park City (picture on Page 10) where the special exhibition of 50 expressive teapots that was anything but ordinary with their history, time and culture and how their function and forms were displayed.

There was an activity for a few brave ladies who wanted to try at making the teapots after the instructor showed them how to do it. They were in a bit of a hurry trying to complete that challenge in 20 minutes and they did!

The survey showed that they tremendously enjoyed the field day. One wrote, "I enjoyed making the tea pot clay to make me give something to do." The other wrote, "Wonderful trip and enjoyed."

Scholarships Available to Deaf Students

The Ned C. Wheeler Scholarship Foundation for the Deaf is pleased to announce that scholarships of \$1,000 to \$1,500 are available this spring for the 2008-2009 academic year, with a deadline of June 30 to apply.

The organization has awarded scholarships to deserving deaf students in colleges and universities for more than 30 years. Awards are given based on student grades, financial need, and maintaining a full time status.

Criteria for qualifying includes three years residency in Utah, GPA of 2.5 or higher with no Ds or Fs in the last three years, proof of deafness, and more. Eligible candidates for the scholarships need to request an application now and gather up all required documentation to be sent in well before the deadline.

Getting to Know UTRID

The Utah Chapter of the Registry of Interpreters for the Deaf (UTRID) is thrilled to contribute to the UAD Newsletter. We realize many may not be familiar with UTRID or the national organization of the Registry of Interpreters for the Deaf (RID). Our hope is to change this and strengthen the relationship between our organizations.

The founding of RID was an unexpected outcome of a workshop held June 14-17, 1964, at Ball State Teachers College (Ball State University) in Muncie, Indiana. The purpose of the workshop was to bring a more formal and structured foundation to the training of interpreters and to upgrade services and support offered to persons who are deaf. Many of the participants of the workshop, which included both deaf and hearing individuals, felt that the formalization of interpreting as a profession was an idea whose time had arrived. After a name change, incorporation in 1972, and various growing pains, RID continued its evolution into its present form.

RID provides support to its membership and the Deaf Community by focusing on continuing education, maintaining standards via testing, maintaining and building relationships, and acting as a resource. One important avenue RID uses to effectively understand the needs of the membership is through its relationships with the affiliate chapters. There are affiliate chapters in 48 of the 50 states as well as in Puerto Rico and the District of Columbia. The Affiliate Chapters of RID are divided into five regions, covering all fifty states, Puerto Rico, and a number of provinces in Canada. Utah's RID affiliate chapter is UTRID. In short, NAD is similar to RID and UAD is similar to UTRID.

We are a support for Utah interpreters but for the Deaf Community as well. It is very important for members of the Deaf Community to be involved in UTRID as well as use us as a resource. Future articles will further highlight why we are not only for interpreters!

A good way to started is to attend the conference coming up June 14-18, 2008 at the Sanderson Community Center of the Deaf and Hard of Hearing. Registration is free! The UTRID board elections will also take place during the conference and we encourage nominations from those who are Deaf and Hard of Hearing.

Booth includes: 1 Long Table, Table Cloth & Access to electricity (Best spots go first). Your company is responsible for extension cords & chairs (if you need them) any other supplies. Camping Chairs work great!

Your company will need to complete the "Single Event Business App" and submit to Draper City by May 5, 2008. We reserve the right to deny any company interested in exhibiting if it does not fit with the race environment.

UAD Board Meeting Motions

October 2007

* Moved to pay \$170 (\$85 each) for the registration fee for two delegates (Trenton Marsh and Jeff Pollock) to attend the NAD Region IV Conference, at the Deaf Center during the weekend of November 2-4, 2007. Due to an extremely busy schedule, Jeff has asked that another delegate be selected. Matt Snarr took his place.

* Moved that Utah Association for the Deaf board members attend the Utah Valley State College (UVSC) Retreat weekend on November 16 and 17 to learn new plans/ways of community vision, a talk given by Ella Mae Lentz, on Deafhood. The roundtable after the retreat would take place for all deaf community members. The cost, \$40.00 per person, will be funded by the UAD Leadership Fund.

* Moved to contribute money for prizes for the Halloween Carnival on October 27. The cost - \$225 (1st prize-\$100.00, 2nd prize-\$75.00, 3rd Prize-\$50.00) - will come from Miss Deaf Utah Pageant fund if admission earnings do not cover the cost.

* Moved to accept the financial committee's recommendation in not developing the partnership with any video phone services.

* Moved to have Eli McCowan check for all non-holiday dates of future board meetings.

* Moved to host an annual fundraising event to support the Leadership Fund with the support of the Social Activity Chair.

November 2007
