Western States Basketball Classic

Have you ever been to an event that, when it was finished, you felt that you attended something worthwhile? Well, this is exactly how it was with 25 of our students at the Western States Basketball Classic (WSBC) this year. This is only the second time we have attended WSBC and already it has become an event that is so worthwhile that I see it as lifechanging.

If you can imagine a gym with over 800(?) deaf people, watching deaf players and cheerleaders from 8 different schools, being officiated by deaf referees and coaches, then you aren't even close to getting an insight to what WSBC is all about. When these kids experience great competition with camaraderie, the thrill of victory as well as fortitude that develops in failure, when they experience overcoming the nervousness of performing and see the leadership of role models, then you're *still* not capturing the full essence of what the WSBC experience does for this community of people. *The neatest thing about this experience is that our students are able to have this experience*.

Most of our students, if not all, would never get to participate in these types of experiences in the public settings they are in. They could attend them but usually only as a spectator and rarely as a participant. Can you imagine going through your high school experience without athletic experiences such as these? The boys' team took fourth place in the tournament and we also won the Sportsmanship trophy. Three of our cheerleaders were picked for the all-star spirit team and there were a number of other individual acknowledgments/honors as well. Our girls' team placed 8th and last. Let me tell you, not only did these experiences give our students confidence, I feel they instilled a sense of accomplishment that will carry over into their school class work (already verified by our teachers), their future vocations, and even influence their posterity.

Now that I've given the philosophical substance of our experience, I'd like to thank the Institutional Council, the administration, and parents for allowing this trip to happen. There were 9 other dedicated adults who coached and supervised and sacrificed their time (over 5 days) to go on this trip who deserve a medal for their role in its success. There were also other staff that helped and businesses that donated to get us there that need to be acknowledged. Thank you all.

If you get a chance, ask any of the students their reaction and you may get a better response to the WSBC experience than what I've tried to share here.

It took \$20,000 worth of technology to upgrade KSL's computer system, so that it could accommodate the closed-captioned technology and provide closed captioning. It'll take another \$40,000 for KSL-TV to "hot key' (add captions to words as they are spoken) live interviews and some weather reports.

What is the Deaf Mentor Program?

Greetings from the Utah Schools for the Deaf and the Blind Deaf Mentor Program under the Parent Infant Program! I am Emily Tanner, the new Deaf Mentor Program Specialist. It is a pleasure to be with the Deaf Mentor Program again. This program is very valuable!

Briefly about me, is that I am Deaf. I grew-up in Salt Lake City, Utah. My parents and siblings are hearing and sign. I attended schools with other Deaf peers where sign language was the primary mode of communication. After graduation from high school, I attended Utah State University and obtained a Social Work degree. I moved to Washington, D.C. to attend Gallaudet University for my Master's degree in Social Work. The experiences of no communication barriers at Gallaudet were wonderful! Students and teachers signed. No third party interpretation was needed. It was an amazing experience that I will always cherish. I have worked as a Mental Health Social Worker, Vocational Rehabilitation Counselor, and the Programs Director of the satellite office of the Division of Services to the Deaf and Hard of Hearing in St. George.

Many of you wonder what the Deaf Mentor Program is and the purpose. The program is established for Deaf children ages 0-6 and their families to learn American Sign Language (ASL) and increase awareness of Deaf culture. My vision of this program is three-folded. Enhance communication between the family and the Deaf child is the main focus. The concern lies on if the entire family and the Deaf child are able to communicate with one another. The second focus is on the language development of American Sign Language. The last part is to increase awareness with Deaf culture with positive interaction, exposure, and opportunities.

The Deaf Mentor Program has Deaf Mentors throughout the state of Utah that are trained to perform weekly home visits to families with Deaf children up to 6 years old. The visits consist of ASL lessons, Early Visual Communication articles and information, other articles on Deaf topics, activities that incorporate Deaf culture and instruction on how to read to your Deaf child. The visits also include hands-on activities outside of the home.

The referral process comes from multiple sources including families, audiologists, early interventions and hospitals. Children under 3 years old are assigned a Parent Infant Program Parent Advisor (PA). The Parent Advisors inform the families about the Deaf Mentor Program and makes referrals as requested. The Deaf Mentor Program is very thrilled to serve families with Deaf children! The communication foundation begins at home with the family and the Deaf child. This is the purpose and goal in helping families build a good rapport with communication and master American Sign Language!

A Familiar Face on the Amazing Race

Luke Adams, an RIT/NTID criminal justice graduate, is the first deaf contestant on "The Amazing Race." He and his mother, Margie, can be seen when the show's next season begins on Feb. 15 on CBS.

CBS Monday announced the 11 teams who will be competing on the next episode of "The Amazing Race." And among the contestants this season is Luke Adams, the first deaf contestant in the popular show's history.



Luke, 23, of Colorado, received a bachelor's degree in criminal justice from RIT/NTID in 2008. For the big race, he teamed up with his

mother, Margie, 51, a clinical research associate.

The contestants must keep the results of the race which was held in October - confidential. Teams are given clues which take them around the world, often to exotic locations. The teams are confronted with physical and mental tasks to complete to receive additional clues. The last team to check in each week is usually eliminated. The winning team during the show's finale shares \$1 million.

This year, contestants travel 40,000 miles and visit nine countries in 22 days. They are faced with "the world's second-tallest bungee jump, bone-chilling Siberian temperatures followed by the suffocating heat of India, and an Olympicsized challenge that leaves teams gasping for air. For the first time in the history of the race, teams will travel to Romania and Siberia," according to a CBS press release.

Bertram van Munster, the show's executive producer/ co-creator, said he wanted to pull out all the stops for this, the show's 14th season.

"We have extreme climates, intense roadblocks and less time in airports, which adds up to an exhausting course for the races," he says. "Whether you're a screenwriter, a Harvard graduate, a jockey or a carpenter, this race will test your stamina, your heart and your will to win."

Other cast members include a team of stuntmen brothers, a pair of flight attendants, a brother-sister team who are Harvard lawyers, and a team of former NFL cheerleaders. During a video interview posted on the CBS Web site, Luke says he hopes to set an example that deaf people can do anything. "A lot of deaf people think you can't go on TV, or shouldn't apply for different things," he says in ASL. "I want to give deaf people hope. That's what I want to do."

Luke and his mother say by using sign language, they

may have an advantage over other team members. They can strategize privately and over farther distances. They also backpacked, hiked and ran more often to prepare for the race.

While at RIT/NTID, Luke was a leading actor in a number of stage productions, including roles in "Laughing Stock," "The Shape of Things," "Macbeth," "A Midsummer Night's Dream" and "Crimes of the Heart."

Jennifer Gravitz, an assistant professor of criminal justice, recalls Luke as "one of the sweetest, most unassuming students I have had the pleasure to work with. He always had a wonderful smile and a kind word - the type of student that makes you smile when he is at the door."

The season premieres at 8 p.m. Sunday, Feb. 15 on CBS. Let's hope he remembered to wear a shirt from his college!

SEC Uncovers Ponzi Scheme Targeting Deaf Investors

The Securities and Exchange Commission obtained a court order halting an alleged Ponzi scheme by Hawaii-based Billions Coupons and its CEO Marvin R. Cooper that was targeting members of the Deaf community in the U.S. and Japan.

The SEC alleges Billions Coupons and Cooper raised more than \$4.4 million from 125 investors since at least September 2007 by holding investment seminars at community centers for investors who were deaf.

The SEC is also alleging that Cooper pocketed at least \$1.4 million in investor funds to pay personal expenses as well as purchase a new home.

This is the latest in a series of investor Ponzi schemes uncovered since the mammoth \$50 billion investment fraud caused by Bernard Madoff was revealed in December.

He lives in Kearns, and was an assistant coach for Jordan High School swimming, and now is looking for a new job. He is currently a student at the University of Utah, but will soon move to Utah State University. He has an average GPA of 3.8.

He has been swimming and playing water polo since as far back as he can remember. His family members, except his parents, are swimmers and water polo players. The Kearns High School teams have a long history of state championships. At one time he was chosen to represent Utah Water Polo in the Moscow-Utah games in Russia during his high school years. He played water polo for the University of Utah for a couple of seasons; and the team won a national ranking of 7th.


