## 20 Years Ago – Letter Regarding Kimberly Clark

Here is additional information I would like to share on the battle against discrimination in Ogden. Perhaps it will make things more clear. Sharon Guerrero fought for the deaf against discrimination. It took many hours and weeks and months of hard work. Her work has helped companies, including Kimberly Clark, to know that deaf people are good workers and can do many kinds of jobs. This will open many opportunities for the deaf in many companies.

Hats off to Sharon for standing up for the deaf people. Sharon left "Ability Utah" to go back to school. Her goal is to someday be a lawyer and continue her noble battle for the rights of all deaf people.

### The U.S. Senate passed the Twentyfirst Century Communications and Video Accessibility Act of 2010 (S. 3304)

The U.S. Senate passed the Twenty-first Century Communications and Video Accessibility Act of 2010 (S. 3304) on August 5, 2010, by unanimous consent! Thanks to the extraordinary efforts of advocates across the country and in Washington, DC, the Coalition of Organizations for Accessible Technology (COAT), of which the NAD is a leader and steering committee member along with other disability organizations, secured a monumental step forward in accessible technology. Earlier this week, Senator Pryor (D-AR) introduced an amendment to improve S. 3304. S. 3304, as amended, was passed by U.S. Senate by unanimous consent. Like H.R. 3101, which was passed on July 26, 2010, S. 3304 will also:

- Require captioned television programs to be captioned when delivered over the Internet.
- Authorize the FCC to require 7 hours per week of video description on the top 4 network channels and top 5 cable channels nationwide.
- Allocate up to \$10 million per year for equipment used by individuals who are deaf-blind.
- Require televised emergency information to be accessible to individuals who are blind or have low vision.
- Require accessible advanced communications equipment and services, such as text messaging and e-mail.
- Require access to Internet services that are built-in to mobile telephone devices, like smart phones, if achievable.
- Require devices of any size to be capable of displaying closed captioning, delivering available video description, and making emergency information accessible.
- Require accessible user controls for televisions and set -top boxes, and easy access to closed captioning and video description.
- And more.

S. 3304 will now go to the House of Representatives. Our coalition, COAT, supports and expects the House will pass S. 3304 soon. Job well done, everyone! Like the Americans with Disabilities Act (ADA) 20 years ago, we are making history now!

#### **Utah Hosts Deaf Japanese Youth**

This year marks 14 years for Deaf Japanese Youth coming to Utah. Every year a group of 5 to 8 students make their way across the Pacific Ocean on to American soil with a final stop here in Salt Lake City, Utah. This year we had 7 awe-some Deaf Japanese youth. Some of them had never met or known each other. They became acquainted during their flight trip to Utah and became very good friends on the way back home to Japan. They live in various parts of Japan.

Throughout their week-long stay here in Salt Lake City, we had 5 host families – some of them took two students and some took one. The host families' responsibilities were to provide them a place to sleep and provide breakfast and dinner. In the evenings the Japanese students experienced what families tend to do. During the day, the International Communication and Education coordinator and I provided sightseeing trips. It was an enriching experience for everyone including host families. The host families and deaf Japanese students learned quite a lot about each other. The Japanese students were in awe at how big the American houses are; we have access to grocery stores 24/7; every house has grassy yards; the freeways are spacious; and finally they were in awe how cheap it is to get a driver's license, and that even deaf individuals could get one.

Two highlights during their stay were 1.Camp at Zion's Peak with other deaf campers. The students' experience camping here in Utah was so different from that of Japan. At home, they do not experience the cold during summer nights in the mountains. 2. Checking their ancestors at Family History Library.

At the end we had a farewell party, along with host families. The students provided a true cultural farewell performance. The next morning I provided a final gift for every student before they left for the airport returning home to their homeland. Some students have kept contact with host families and with Ron and me. Some of them wish to return to Utah. A few want to continue their higher education here. We told them that they are always welcome here.

We will see how that goes next year. That is if some return like some did come two years ago when they first came three years ago.
