## Utah Deaf Trivia

**Q:** What two Utah people received honorary doctorates from Gallaudet University the same year, and what were they famous for?

**A:** Ray Wenger and Arthur Wenger received honorary degrees of Doctor of Science in 1973 from Gallaudet College (as it was then called) at the age of 80. They were called Utah's twin gift to science, education and community service for the deaf. The Wenger Laboratory was established in Salt Lake City in the 1930s, a bacteriological-chemical laboratory which gained a favorable reputation in Utah. Arthur passed away in 1975 and Ray in 1984.

Excellent articles on the Wenger twins appeared in the Winter 1964 issue of the UAD Bulletin and in the January 1974 issue of The Deaf American.

### How Can We Help JMS?

Box Tops and Labels: Box Tops for Education--each one is worth 10 cents; Campbell's soup and assorted products - only the front of the label is required. One point per label is banked for equipment. These can be left at the Deaf Center, sent to JMS at 1539 West 12600 South, Riverton, Utah 84065, dropped off at the Interpreter Training Program (ITP) office at Salt Lake Community Center in Taylorsville, mailed or dropped off at the Broetz home at 3497 West 5660 South, Taylorsville, Utah 84118

Smith's: This works for those who have Fresh Values card. Go to the store, and fill out a Earn & Learn Enrollment form. Where it asks for "Designated School/Organization" put down Jean Massieu School in

Riverton, Utah. Each time you shop at Smith's, have your Fresh Values tag scanned, and up to 5% of your Smith's purchases will be earmarked to JMS.

Albertson's: We will be getting more cards, and they can be picked up at JMS or the above address, as soon as they come in. Do the same thing with that card, when you shop there, even prescriptions, film, cleaning.....it all works.

Target: If you have a Target charge card, go to the front of the store, and let them know you want the form to fill out what school you want a percentage of your purchase to go to.

Suckers: This is JMS's largest profit, and JMS earns 50% of every sucker. The suckers sell for 50 cents and the school gets 25 cents. Mrs. Broetz is looking for people who have offices or work in places that would be willing to allow a small display to be there. The person agreeing to it would be responsible to collecting the money, and returning it to Mrs. Broetz.

Donations: There is also the idea of asking the company you work for to consider donating to the school. It does not hurt to ask, as they might be looking for a project that would be of course be tax deductible for them, and benefit the youth of tomorrow.

### 1960's Hearing Educators Say Oralism Wasn't the Answer

I found the article in my papers from my days in elementary school. I always kept interesting articles from newspapers. As the years passed, I did not want to be a pack rat but I could not throw away this article. It was printed in a newspaper approximately 35 years ago. It was written by Dr. Walter C. Alvarez, an M.D. Emeritus Consultant in Medicine, Mayo Clinic and Emeritus Professor of Medicine.

I didn't think there were many hearing people back in those days who were on our side when it came to what mode of communication is best for deaf children in the educational system. I remember years and years of battling between the sign language and oral groups. This article explicitly stated that teaching deaf children to lip-read should not be the primary mode because of their inability to hear sounds.

I have a deep interest in the lives of deaf children and their education. I have always had a strong belief that sign language is the best mode of communication with deaf children. I know this for a fact because I grew up as a deaf child - I have experienced both methods. One method where I was not allowed to use ASL in the classroom and the other method where I was allowed to use ASL anytime I wanted to.

Dr. Alvarez wrote, "Dr. Helen Thompson of Yale University stated some years ago that she felt that the deaf child should be given, with finger speech (sign language), a large store of information and ideas, before lip reading is even attempted - perhaps not until the child is 9 or 10 years old. Dr. Hans Furth, a psychologist, agreed and says that deaf children of deaf parents began early to talk with their fingers, and as a result, when they go to a school for the deaf, they are immensely better prepared for their studies than are the deaf children who have not had conversational contacts with the world. Hence, Dr. Furth urges all parents of deaf children to quickly learn the finger language, and then to talk often to the children so as to give them a store of information".

What did those people know that we know now? I ask you: Why is the Deaf Mentor Program so successful? The Deaf Mentor Program is spreading across the America like a weed. It is not happening overnight but it is spreading. The answers are obvious.

# The Utah Jazz TEACHERS FOR ALL 2002 Scholarship Application

The Utah Jazz Teachers for All scholarship seeks applicants who wish to become teachers and who have experience, skills and dedication to work with some very special students. Specifically, we wish to increase the number of **bilingual** and English as a Second Language (**ESL**) teachers, **special education** teachers, teachers from **minority communities** and teachers trained to work with **deaf or blind** students.

Our goal is to add to the teaching ranks, talented men and women who represent the diversity of our communities, who have the skills to reach language minority students or who are committed to providing a quality education to disabled students.

Twenty \$1,000 awards will be granted. Funding is directed to prospective or current teachers working towards:

- Special education certification
- ESL endorsement
- Certification/endorsements for teaching the deaf or blind
- Teaching certification (for minority and bilingual applicants)

Applicants will be judged on one or more of the following:

- Experience or public service in minority communities
- Interest in working with physically, mentally or behaviorally disabled children
- Foreign language ability

## GENERAL INFORMATION

- Applicants may be high school seniors, current college students or adults not in college, but who have completed a high school diploma and qualify to enter a teacher preparation program.
- All applicants must demonstrate high academic achievement and provide recommendations by those familiar with applicant's work.
- Applicants will be notified of the committee's decision by March 15, 2002.
- Scholarship money will be sent directly to the college or university of the winner's choice.
- Please include a photograph, if possible. Winner's pictures may be published. Photographs will not be returned.

# 2001 Accomplishments



**With your support, the NAD has accomplished quite a number of activities this year to improve the lives of deaf and hard of hearing Americans.**

**Highlights of these 2001 accomplishments include:**

## **Youth Programs**

The NAD held the first ever-Collegiate NAD Conference with college student representatives from California State University at Northridge (CSUN), Gallaudet, National Technical Institute for the Deaf (NTID) at the Rochester Institute of Technology (RIT), and Southwestern Collegiate Institute on Deafness (SWCID). The 2001 National Jr. NAD Conference was recently held in Columbus, Ohio with 75 students and advisors in attendance.

## **Government Affairs**

The NAD sent a letter to President Bush on New Freedom Initiative for Americans with Disabilities, urging the appointment of qualified deaf and hard of hearing persons to key federal positions and pointing to the need for accessible programs and services across the board.

## **Education**

The NAD co-hosted the National Symposium on Childhood Deafness in Sioux Falls, SD with Communication Service for the Deaf (CSD) and the American Society for Deaf Children (ASDC). Our deepest appreciation goes to Frank Turk of CSD, who successfully orchestrated the star-studded Symposium program, drawing over 400 participants. Plans are under way for the next Symposium in 2003.

## **Technology/ Telecommunications**

The NAD won a partial victory on Instant Messaging when the FCC announced approval of the AOL-Time Warner merger, with certain aspects of Instant Messaging interoperability included among conditional requirements. The NAD also filed comments with the FCC on a variety of issues, including emergency alert systems, relay services, and broadband telecommunications.

## **Movie Captioning**

The NAD provided testimony to the Connecticut state legislature to support open- and closed-captioned access to movie theaters. The Coalition for Movie Captioning (CMC) and various state advocacy groups, including the Connecticut Association of the Deaf, also gave testimony.

## **Emergency Warnings**

The NAD prepared a comprehensive fact sheet – now available on the NAD website – on emergency warnings and notification, which covers television and radio announcements, civil defense and weather alerting systems, and police-related communications.

## **Sign Language Interpreting**

The NAD continues to work closely with Registry of Interpreters for the Deaf via the NAD-RID National Council on Interpreting toward the development of a joint national sign language interpreter assessment and certification system.

## **State Associations**

The NAD responded to requests for assistance by the North Carolina Association of the Deaf by contacting key legislators in North Carolina and issuing a rally statement that successfully opposed threatened closings of two NC state schools for the deaf.

## **Legal Rights**

The NAD received national recognition for legal action efforts in a landmark New Jersey settlement, which resulted in monetary awards to the deaf defendants involved. Also included was a memorandum of understanding with the State of New Jersey to ensure access by deaf and hard of hearing people to municipal courts.

## **Captioned Media**

The NAD entered into a new five-year, \$17.25 million cooperative agreement with the U.S. Department of Education for continued management of the Captioned Media Program (CMP). The CMP provides education and outreach information on captioning, available through the NAD website.

## **September 11th Disaster**

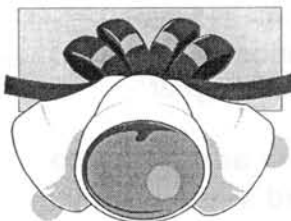
